

CANTON PUBLIC LIBRARY BOARD RESOLUTION CERTIFYING RATE FOR TAX LEVY

WHEREAS, the Canton Public Library Board did on September 18, 2025, conduct a public hearing on its proposed budget for fiscal year ending December 31, 2026, and;

WHEREAS, after the conclusion of said public hearing, the Canton Public Library Board did on September 18, 2025, adopt a budget for fiscal year ending December 31, 2026, that the total amount of \$8,596,500 a copy of said budget being attached hereto, and;

WHEREAS, taxes for said fiscal year will be collected in December, 2025 and;

WHEREAS, based on the taxable value of property in the Township of Canton, a levy of 1.4202 mills will result in a tax of \$8,243,143 and;

WHEREAS, the Canton Public Library is in need of \$8,243,143 in tax funds in partial support of the library as set forth in the attached budget;

NOW, THEREFORE, BE IT RESOLVED, that a certified copy of said budget for fiscal year ending December 31, 2026, and of this resolution be transmitted to the Township Clerk of Canton Township not later than September 30, 2025, for levy and collection of 1.4202 mills for Canton Public Library, which rate is hereby certified pursuant to Section 10, 1877 PA 164, as amended, and governing tax laws.

IT IS HEREBY CERTIFIED, that the attached budget was adopted by the Canton Public Library Board at its meeting of September 18, 2025, at which a quorum was present and voted to adopt said budget; and that the sum of \$8,243,143 is the amount of tax funds required to support said library for fiscal year ending December 31, 2026, and that 1.4202 mills is the rate necessary to be levied to produce said amount required by the library.
